Please read all these notes carefully before completing your application form. Failure to complete the application form correctly will result in your application being delayed. The committee has the right to refuse applications for Associate Junior Membership. Associate Junior Membership Cards will be valid until 15th June 2021.

Note 1 Personal information you provide will be held on the SDAA Ltd members register computer database and will not be passed on to any other organisation. If you provide phone numbers and/or an email address it will be assumed that you have no objection to these being used by the club to contact you.

Note 2 If the Member has already purchased a Membership Book, the current membership book number **must** be inserted, which is printed in the top right hand corner of the page containing your name and address. If applying for both an Associate Junior Membership Card and your own Membership Book leave this blank, but you must include a separate application form for your own membership.

Note 3 Please state the Member's relationship to the child applying for Associate Junior Membership.

Note 4 The upper age for Associate Junior Membership is in line with the EA Junior rod licence, i.e. an EA Junior rod licence is required for persons who have reached the age of 12 but have not reached the age of 17).

Note 5 Associate Junior Membership is free, but subject to the following additional rules:

- Associate Junior Membership Cards must be carried at all times whilst on club waters.
- Associate Junior Members can only fish whilst supervised by the Member shown overleaf.
- Members and their Associate Junior Members must occupy the same swim.
- Associate Junior Members can only fish with one rod.
- Associate Junior Members cannot fish IPA waters.
- Associate Junior Members are not permitted to vote at the AGM.
- Associate Junior Members can claim specimen trophies.

If the junior wishes to fish their own swim or with two rods, they must first purchase a full Junior Membership Book. Full Junior Members aged 12 and over can also fish unaccompanied (with parental consent), except whilst night fishing.

Note 6 Associate Junior Membership And Night Fishing

- The SDAA committee has decided to extend the concession on night fishing for Associate Junior Members. This is still being run as a trial, which may be modified or withdrawn without notice.
- This initiative is designed to allow Associate Juniors to sample the experience of night fishing at no charge. The adult Member must judge whether the Associate Junior is capable of actively fishing at night or whether to just enjoy the 'camping' experience.
- Adult Members (aged 18 or over) can be accompanied by a single Associate Junior whilst night fishing SDAA waters provided prior permission has been granted by a parent/guardian by signing the declaration on the Associate Junior Membership card. The adult Member must be in possession of the appropriate adult night permit whilst night fishing The Airman, Broom Lake or Wellington Lake.

Note 7 The form must be signed by a parent/guardian. If the parent/guardian is not the Member who will accompany the child, they must also provide their contact details. **Please note that due to additional rules introduced to help conform to government guidelines on social distancing Juniors and Associate Juniors are currently not allowed to fish unless accompanied and supervised by a member from the same household (or 'support bubble') aged 18 or over.**

Note 8 Adobe 'Fill and Sign' is usually present from the 'Tools' menu if you open this PDF on a PC or laptop. A free Adobe 'Fill and Sign' App is available to download for most mobile devices (phones and tablets). Whilst using 'Fill and Sign' if you waive the cursor over a set of boxes, it should turn blue, and then when you click your typing should neatly fill in the boxes. Once you have filled in the form save it as a file including your surname in the filename and attach the file to your email application.
